1 General

The purpose of processing of your personal data is to operate our website with information about IT security training and the presentation and offering of goods / services on this topic.

The server on which this website is hosted is located in Frankfurt am Main and is operated by binsec GmbH, Europa-Allee 52, 60327 Frankfurt am Main. Further details are available at https://binsec.com.

2 Server-Log-Files

Every time you access our website, usage data is transmitted by the respective Internet browser and stored in so-called server log files, such as the following: Date and time of retrieval, name of page accessed, amount of data transferred and requesting provider. This data cannot be associated with individual persons and serves solely to ensure undisturbed operation of our website and to improve our offer.

3 Cookies

In order to make the visit to our website attractive and to enable the use of certain functions, we use so-called cookies on various pages. These are small text files that are stored on your device. Some of the cookies we use are deleted after the end of the browser session, ie after closing your browser (so-called session cookies).

Other cookies remain on your device and allow us or our recipients to recognize your browser on your next visit (persistent cookies). You can set your browser so that you are informed about placements of cookies and decide individually on their acceptance or exclude placements of cookies in general or for specific cases. If you do not allow the placement of cookies this may limit the functionality of our website.

4 User account & Registration

This data is stored for the duration of usage and in a form which allows your identification only for as long as necessary for the purpose for which it is processed.

If you would like to have your user account deleted, you are always welcome to contact us.

Please note, however, that at least on paid orders, storage requirements for certain data (e.g. UGB or tax law) exist and we therefore store a copy of your invoice. In these cases, data is not erased but it's usage is restricted.

User accounts without having ordered paid services and their data will be reviewed annually as to whether data can be erased. We particularly also take into account whether accounts are still actively used.

5 Performance of the contract

This data will be transmitted to binsec GmbH, Europa-Allee 52, 60327 Frankfurt am Main, otherwise as necessary to the following:

- Banks (payment transactions)
- Tax advisor (accounting)
- Collection agencies (debt collection)
- Legal representative (law enforcement)
- Courts (law enforcement)
- Administrative authorities

This data is stored in a way that allows your identification only for as long as it is necessary for the purpose for which it is being processed.

Generally, this data is erased at the end of the seventh year after the last receipt has been entered in regards to the concluded contract (retention period; § 132 BAO).

Statutory/legal retention obligations and contractual obligations, e.g. against customers arising from warranty or compensation obligations or against contracting parties are a basis to continue to store this data.

Generally, this data is erased at the end of the third year after our last contact with you, unless other retention periods apply (see above).

8 Google Analytics
